**Agreement** This agreement is between KWaldrup Studio & Design. (Photographer) and the "Responsible Party" (Client) as designated below. The Photographer agrees to provide wedding photography at the places, dates, and times specified in the "Wedding Info & Estimate." If, for any reason, he/she cannot fill that obligation, the Photographer must provide a substitute of his/her choosing to provide the same service. The \$216.00 non-refundable deposit secures the dates and times for photography. Although the deposit is not refundable, if photography is cancelled, it will remain as a 1-year studio credit toward any photography or prints. The Client agrees to pay the balance of the payment at least one week prior to the event. **KWaldrup Studio & Design-** The photographer will do his/her best to capture the day in a manner that is pleasing to the clients. KWaldrup Studio & Design. is not responsible for capturing images that aren't requested. The photographer is experienced and will, by default, seek to organize the wedding party for many of the traditional photographs (as well as spontaneous candid shots as time and circumstances allow). However, weddings involve many unforeseen circumstances that sometimes preclude the taking of certain pictures. These circumstances may include time constraints, late members of the party, late bride or groom, or even the client desiring a shot, but forgetting to ask for it. Because the client is responsible for requesting specific shots, KWaldrup Studio & Design offers a list of possible shots that the client may approve before the event. Even with this list of desired photographs, the client hereby agrees that **they** maintain the responsibility of seeing that any specific photographs are taken. This is done by reviewing the photography list with the photographer prior to the wedding day, so the client can prioritize photographs as wedding circumstances change and may necessitate the altering of the list. KWaldrup Studio & Design will be the coordinator of all photographic images on that very special day. **Image Rights and Format** The Photographer maintains full rights to images photographed under this agreement, and may reproduce them in any form as well as license the rights commercially. If purchased or included in a Wedding Package, the Client receives a permanent license to the images for **personal use** and reproduction (including printing and emailing). The client may not use the images for commercial purposes. The client that purchases a wedding package that includes as CD with copyrights, or purchases a CD ala cart will receive all of the full resolution images on archival CD-R's and in the JPEG file format. Images will receive basic color and exposure corrections. Reproduction quality will depend on the properties of the devices that the images will be printed to. Clients are encouraged to use professional (custom) labs or KWaldrup Studio & Design Printing Services to get best results.

**Receiving Images** The client will be emailed a document for ordering and selecting favorite images for the custom albums that are either included in the wedding packages or purchased and/or prints. The client may order the prints at anytime - but after one year from the date of photography, KWaldrup Studio & Design will charge a \$50 un-archiving fee to fulfill the any print orders from packages. However, if the client makes a paying order of \$50 or more, the fee is waived. If the client selects the wedding package with the CD option or purchases a CD with full rights, once the client has the images on CD, KWaldrup Studio & Design. is not obligated to have the files on hand - however, KWaldrup Studio & Design does archive and back-up every image, so the images should always be available through them. **Limited Liability** The Photographer's liability is limited to fulfilling this agreement or to return all deposits made by the Client. **Being on Time** Both the Photographer and Client are expected to be on time and ready for photography according to the times stated above. If the client or anyone from their party is late, the time the photographer spends waiting will still be counted towards the time agreed upon in this contract. Additional photography time can be added for any reason at the time of the shoot, but the Client agrees that time will cost an additional \$50/half hour. If the Photographer is late, the time the client spends waiting for the Photographer is NOT counted toward the time agreed to in this contract, and the photographer is obligated to fulfill the full amount of time agreed to in this document. **Sole Photographer** KWaldrup Studio & Design is the SOLE photographer responsible for capturing and creating images of your wedding. While we do work with others involved in your special day, KWaldrup Studio & Design reserves the right to create based on the agreement of this contract.
